# Application Requirements for Retail Sale of Fireworks

- A State Fire Marshal's License for retail sale of fireworks must be obtained from:

Olympia Office  
Washington State Fire Marshal  
Insurance Building  
Olympia, WA 98501

Two copies of the State Fire Marshal's License will be submitted with the application. The license will be posted on site, **after** being signed by an inspector from the City of Chewelah.

- Proof of insurance coverage** as specified in RCW 70.77.270(3)
- A **Site Plan** of the proposed location of the fireworks stand shall be drawn to scale in an 8 ½ x 11 diagram. This diagram shall show the size of the stand; distance from the stand to structures, buildings, fire hydrants, other stands and streets; and parking areas.
- Written Authorization from the property owner which allows use of the site.

## **The Fireworks Permit Fee of \$50 must be submitted with the application.**

The completed application package must be returned to the City of Chewelah no later than June 15<sup>th</sup>. **Any application received after June 15<sup>th</sup> will not be approved.** Packets may be mailed or delivered in person.

The Fireworks permit will be issued to the applicant at the time of inspection of the fireworks stand. The location of the stand shall be as shown on the approved site plan.

The "Person in Charge" / Applicant" (as listed on the application) will be notified when a Permit application is approved.

Approved and licensed fireworks stand are subject to inspection during periods of operation. Strict adherence to established rules and regulations is mandatory.

**The "Person in Charge" will display a copy of Ordinance 627 of the City of Chewelah Municipal Code in a prominent place at the point of sale.**
