REGULAR COUNCIL MEETING

January 17, 2024

Audience Comments:

• Chuck Ritchie, President of Chewelah Creative District – Presented an updated letter for Council to sign to allow the Creative District to apply for the \$70,000 grant to be able to do the improvements in the park that will include new spaces for vendors, some art pieces, a base for a rotating art sculpture gallery.

<u>Approval of/Changes to Proposed Agenda:</u>. Councilwoman Ling asked to add the Creative District letter presented under Old Business. The Mayor stated the administration wasn't ready to introduce Ordinance 990 Moratorium on Behavioral Health Facilities, it will be moved to the February 21st Council meeting. *Motion by Councilwoman Ling <u>to Approve</u> the Changes to the Agenda as Amended, seconded by Councilman Kabosky. Roll call vote taken with all in favor*. Motion carried.

• Mayor McCunn restated that the committees can choose a chairperson as the state law RCW gives you full authority to design and run your committee meetings as you see fit, including selection of a chairperson.

- Repurpose the middle school for NEW Health University
- Contracting with The Keller Group for applying for a \$150,000 grant, to replace 20 trees on Main Avenue by DNR.
- Sety's rebuild

City Administrator's Report (including):

- Councilmen McCoy and Carpenter will be attending the AWC conference in Olympia February 6th to 8th.
- The February 7th Council meeting will have several people on the Council missing. With Councilmen McCoy and Carpenter in Olympia and the Mayor and myself in DC, there will be 4 Councilmembers in attendance. It is up to the Council if the meeting should be canceled.
- We will be postponing the seating of the Council At-Large position. Due to an error in the information sent to the Independent, we have extended the deadline to February 14th.
- Civic Center has been closed due to a catastrophic heating failure.

Discussion regarding the Chewelah Creative District and how they are doing this right, this is a good recommendation/upgrade. Roll call vote taken with all in favor. Motion carried.

Roll call vote taken with Councilmen McCoy, Kabosky and Carpenter abstaining, Councilman Nupp voting against, Councilwoman Ling and Councilman Alvarado voting in favor. Motion failed.

Discussion regarding the impact of not having a contract with the City Attorney. Motion by Councilwoman Ling to <u>Approve Contract Between City of Chewelah and</u> <u>McGrane & Schuerman</u>, seconded by Councilman Kobosky. Roll call vote taken with Councilwoman Ling, Councilman Alvarado, Kobosky and Carpenter in favor. Councilman McCoy and Nupp abstaining. **Motion carried**.
