



This is a quotation and an offer of service made by Tree Pros Northwest LLC to the City of Chewelah (hereinafter, "Client").

The proposed start date for this project is April 21, 2022. The work is expected to be completed in five day(s).

Terms:

Tree Pros Northwest LLC hereby offers to provide Client with the following services:

- 1) **The scope of work** is to safely perform mechanized grapple cleanup of branches and downed tree trunk sections within a generally triangular area between Sand Canyon Rd. and Richmond Ln. from the street intersection to the area of the aircraft hangars.
 - a. Area will be raked with a grapple to collect branches and other tree debris. Debris will be stacked into piles sufficiently distant from live standing trees to enable burning by Client at a later date. After collection and stacking of debris from the area into piles, the area will be back-raked with the grapple to rough-level the area.
 - b. Remove a stack of Ponderosa Pine logs from trees that had been previously cut from trees in a cleared area near the hangars. After deducting the loading and trucking costs the logs are estimated to have a value of about \$200.00 (two hundred USD), Tree Pros Northwest LLC would be willing to apply to the cost of the above cleaning services.
 - 2) **Total cost** for the offered scope of work in section 1) above is \$3,200.00. Applying the residual value of the logs as described above leaves a cost of \$3,000.00. A deposit in the amount of 20% is required to reserve the work date on the schedule. Credit and debit cards, checks, and cash, are all acceptable forms of payment.
1. Tree Pros Northwest LLC maintains a general liability policy of \$1,000,000.00 (one million Dollars) per occurrence covering any liability that Tree Pros Northwest LLC may incur during



the performance of the above described tree services. Certificate of general liability insurance is supplied with this quotation.

2. If a delay in completion is caused by Tree Pros Northwest LLC, Tree Pros Northwest LLC agrees to reduce the amount Client must pay for services rendered by \$200 (two hundred Dollars) per day for every business day the completion of the project is late past an initial 3 (three) business day grace period. Tree Pros Northwest LLC will not be held liable for work delays beyond its control, (including delays caused by weather and/or soil conditions).
3. Tree Pros Northwest LLC is responsible for abiding by all building regulations, fire codes, and worker safety laws, and Tree Pros Northwest LLC shall be solely responsible for any fines or penalties arising because of a failure to abide by the above legal regulations, codes, and/or laws. Further, Tree Pros Northwest LLC shall pay for any damages caused by the negligence of Tree Pros Northwest LLC or of any employee of Tree Pros Northwest LLC.
4. If the project includes any underground work (stump grinding, stump removal, etc.), Client agrees to provide Tree Pros Northwest LLC with the location of all subsurface utility and service lines that may reasonably present a hazard during the tree service work specified herein, including water and gas pipe lines and electrical lines. The Client assumes full responsibility for the accuracy and completeness of the information provided to Tree Pros Northwest LLC and agrees Tree Pros Northwest LLC will not be held liable for any damage caused by inaccurate or incomplete information.
5. If authorization or permit to perform the above described work is required from any organization or agency (e.g., without limitation homeowners' association, government agency, etc.) Client represents that Client has obtained any such required authorization or permit.
6. Client agrees to provide Tree Pros Northwest LLC with the property access needed to fulfill the services offered in this quotation.
