- Public Works, Councilwoman Ling Reported City Recycling/Plastics should have a report by Nov. 1, 2023. City Administrator, Caruso provided explanation of the issue of cost to take it to Spokane.

- Motion by Councilwoman Ling to approve Ordinance 984 Procedural Code Update, seconded by Councilman Nupp. Roll call vote taken with all in favor. Motion carried
- Motion by Councilwoman Ling to approve Ordinance 985 Beekeeping Ordinance, seconded by Councilman Schalock. Roll call vote taken with all in favor. Motion carried.
- Motion by Councilman Kabosky to Approve Council Wage Increase to \$360.00 per Month, seconded by Councilman Nupp. Discussion by Councilman Kabosky regarding his method of research for calculating the increase. Councilman Schalock questioned why this wasn't being discussed during the Budget Workshops. Councilwoman Ling commented on the amount of research she had done to gather information from different cities. She additionally requested a commitment to produce as a council in exchange for this raise. Roll call vote taken with Councilman Alvarado voting against, Councilwoman McGee and Councilman Schalock abstaining, all other votes in favor. Motion carried.

# Comment:

Councilman Kabosky requested consideration to put a potential policy in place in Chewelah for asylum seeker and refugee relocation. Mike Waters, City Attorney strongly suggested research into this request. "I think if this is something the Council wants to look at, it should be more judiciously considered and researched before it comes before the Council."
